

## **Doctrine Announcements: (30 JAN 2026)**

1. A new edition of the *USMC Dictionary* was published in December 2025. It is available on the USMC Doctrine Library website.
2. TECOM G3 transitioned the VCE MCTC website to SharePoint architecture. TECOM G3 VCE website contains 24 MCRPs that were “divested” from USMC Doctrine Library by DC CD&I. The TECOM G3 Share Point website allows you to download or view publicly releasable MCTCs (aka “divested” MCRPs). There’s one LIMDIS MCTC (*Engineer Field Data*). Those needing to view this pub need to request permission from TECOM G3 MCTC website manager, Mr. Horace Vinson. The hyperlink on MCES S3 Doctrine Branch homepage will connect you to the TECOM G3 MCTC SharePoint website. You’ll be able to view/download publicly releasable MCTCs.

As you first open the website, you’ll be asked to request access before you can view/download pubs. Recommend requesting full access if you need to view pubs containing critical unclassified information (CUI). After requesting access, you’ll receive email acknowledgement your access has been authorized. Marines assigned to commands that use another Service’s email domain (e.g., @army.mil, @navy.mil) must request access or use USMC email domain account (@usmc.mil).

4. The Navy’s Expeditionary Warfare Development Center (EXWDC) is leading the IPT revision of NTTP 3-10.1M/MCTP 3-34D, *Seabee Operations in the MAGTF*. Pub’s title was changed to *Integrated Naval Formations – Expeditionary, Engineering* to align with other naval expeditionary pubs. **On 12 Jan 2026, multi-Service comments received from WWS of the first draft edition were adjudicated. Navy author anticipates that a final draft edition will be distributed for WWS by the end of March 2026.**
5. **Based on the results of a 2024 Front-End Analysis, EXWDC has begun development of a new TACMEMO, TM 4-04.2.1-26, *Engineer Reconnaissance and Assessment*. MCES is advising the Navy IPT during the development of this Navy-only pub.**
6. The new forms that are described in ATP 4-44/MCRP 3-40D.14, *Water Support Operations*, **have been loaded to the DoD Forms website as DD Forms 1712, 1713, 1713-2, 1713-3, 17-15, 1715-1, and 1717. Before the forms can be used, they must be downloaded and saved to a computer. Then they can be viewed and information inserted by using Adobe software (activate enable function first).**
7. **Errors in Table E-2 of ATP 4-44/MCRP 3-40D.14 were discovered by a keen-eyed CWO2. MCES is working with the Army Proponent to make a change to the pub (IOT remove the table and replace it with a corrected one). The table provides chlorination dosing values for various quantities of bulk water.**
8. **MCES has submitted a change package for MCWP 3-34 to the Doctrine Branch of TECOM. The change will cause DA forms for water support to be removed and replaced with DD forms (in appendix D), insert two new DD forms for environmental matters (into appendix D), and update information about several multi-Service engineering publications (USAF, USN, JPs).**
9. Army’s Maneuver Support Center of Excellence (MSCoE) is developing a new Army-only pub, *Engineer Platoon*. It’ll consolidate information from TM 3-34.85/MCRP 3-34.1, *Engineer Field Data*, in appendices. Then, *Engineer Field Data* will be cancelled. MCES was notified of Army’s plan and issued a request for feedback (RFF) questionnaire across the Service. Feedback received will be used to

determine whether to retain *Engineer Field Data* as Marine Corps-only pub and decide which information should be retained, revised, eliminated, or added. Evaluation of feedback has restarted.

10. MCES is working with the PEO Digital End User Services office, Marine Corps Systems Command, to get Joint Construction Management System (JCMS) version 5.0.3.1 loaded to the Software Center. This version includes new designs such as displaced persons camp, temporary wood/CMU/PEB structures (armory, chapel, dining facility, post office, admin office, ops office), detention center, roads, runways (concrete, asphalt, earthen, AM2), and metric CMU designs for EUCOM and INDOPACOM AORs). The JCMS program office is working to field version 5.1 in **March-April 2026**. Version 5.1 will allow users to modify drawings **without** having to import the drawings into AutoCAD software. **MCES beta tested version 5.0.3.1. MarCorSysCom will remove version 5.02 and replace with version 5.0.3.1 in the USMC Software Center. Installation instructions for version 5.0.3.1 will need to be followed to successfully download and install JCMS Launcher and the Design and Construction application.**

11. MCES is working with staff of US Army Corps of Engineers Reachback Operations Center (UROC) to have 2015 edition of IPC removed from Reference Library of the Reachback Engineer Data Integration (REDi) portal and replaced with 2024 version. UROC obtained approval to post onto REDI portal. **Await posting.**

12. The US Army Engineer School and MCES have been revising TM 3-34.82/MCRP 3-34.2, *Explosives and Demolitions*. **MCES reviewed the Army's Initial Draft and found errors. Await corrected draft from the Army before pub is distributed for WWS as a coordinating draft.**

13. EXWDC revised NWP 3-10, *Naval Expeditionary Combat Forces*. Pub is Navy only but includes feedback provided by USMC SMEs. **Await signature.**

14. MCES is collaborating with MAWTS-1 during revision of MCTP 3-20B, *Aviation Ground Support*. MCES provided feedback about the coordinating draft edition via CRM. MCES is monitoring the Air Force's revision of AFTTP 3-32.17, *Rapid Airfield Crater and Spall Repair*.

15. During Army's Doctrine Developers' Forum, CASCOM announced the development of a new Army Techniques Pub, ATP 4-4x, to address TTP for showers, laundry, and contingency base support/services. MCES is negotiating multi-Service partnership with the CASCOM staff.

**16. Feedback provided by MCES and LPE was accepted by the author of water content contained in JP 4-03, *Joint Bulk Petroleum and Water Doctrine*. Full revision of the pub will begin in March. HQDA DCS G4 discussed revision during 29 Jan MS TEAMS mtg with Army/Marine Corps water SMEs.**
