

ADVANCE WATER SUPPORT TECHNICIAN (CID: M03UAC2)

PREREQUISITES: Graduate of the Basic Water Support Technician Course (CID: M031102) or any 11XX MOS that has already completed their original MOS pipeline advanced course requirement. Students must have a minimum one year of MOS experience and have a minimum of one year obligated service upon graduation. Due to the advanced nature of this course, waivers for LCpl's will be considered on a case-by-case basis only, with special consideration given to Marines who are the sole duty expert 1171 within their section or company. The Director of Instruction, Marine Corps Engineer School is the waiver authority.

OUTCOME: To provide designated advanced level training to Water Support Technicians (MOS 1171) in compliance with the training continuum required by the Operating Forces.

SCOPE: This course is designed to impart the advanced knowledge and skills required to supervise a water section and plan/provide water and hygiene support. The course consists of instruction in the planning and supervision of finding and developing water sources; water purification, storage and distribution; and hygiene support in a field environment; along with the assessment and planning of plumbing systems of structures, while complying with applicable codes. Course also involves establishing code compliant plumbing systems along with installation procedures. Values Based Leadership (VBL) training will be conducted.

REPORTING INSTRUCTIONS:

Students report to Commanding Officer, Marine Corps Engineer School, Courthouse Bay, Camp Lejeune, North Carolina.

Government billeting is directed if available. Government messing is available.

Government billeting is available and located at Courthouse Bay or various other locations at no or low cost for Staff Sergeants and above. To verify availability and for more information, contact MCES S-4 at COMM: (910) 440-7890 / DSN: 758-7890.

*EXCEPTION: Those students from the local area approved for BAH at their parent command.

During working hours, report to the S-1/Adjutant at Building BB-28 (Headquarters, MCES), second building on the left after entering Courthouse Bay (at the intersection of Horn Road and Command Drive).

After working hours, report to the AOOD at Building BB-28 (Headquarters, MCES), second building on the left after entering Courthouse Bay (at the intersection of Horn Road and Command Drive).

All students will report in with orders, Medical Record, Dental Record (electronic or hard copy) on reporting date. A Command Screening Checklist can be obtained online at MCES website at <https://www.mces.marines.mil/> to ensure students meet requirements.

Students will report in appropriate seasonal Marine Corps Combat Utility Uniform (MCCUU).
